

Company Structure


- Corporation



- Only employee panel
- Chairman of the EWC = Chairperson of the German work council
- Representatives will be elected in accordance with their national custom
- Representatives will hold office for 4 years

EWC Coordination II

- GM will pay the cost
- Trainings (language training, etc)
- E-Mail, Fax and telephone
- Members are protected by national law
- Obligation of secrecy
- 2 external experts
- In case of disputes: Belgien law

European Employee Forum

- Pure Information and Consultation panel
- No rights of codetermination
- Bad implementation law
- Implementation of trade unions
- Improvement of the hearing law
